As an opportunity for local artists to display their art to the public, the National University of Health Sciences (NUHS) Art Gallery, managed by the Lombard Arts Coalition (LAC), will be hosting their annual "juried open" fine art show.

Artwork will be on display in the gallery from Wednesday, October 5th thru Monday, December 5th, 2011, with an art **opening reception** taking place on **Sunday, October 16th from 1 to 3 p.m.**

Artwork will be judged. Winning pieces will be eligible to enter the Alliance of Fine Art's "Best of the Best" Show to be held in Spring of 2012.

*In order to be considered for this juried art exhibit,
the criteria on the back of this page must be met:*

Application Postmark Deadline: Sept. 15th, 2011

(OVER)

1. **Application** must be entirely completed and postmarked by September 15th, 2011, with a non-refundable **\$10 hanging fee*** included (checks made payable to LAC).
2. **Photos of the artwork** must be included with the application. A **maximum of three works** per artist may be submitted for consideration with a maximum of **two photos each**. The number of pieces that will be accepted per artist will be determined by space available and the number of artists applying to participate in the show.
3. A **statement of release** must be filled out, signed, and returned with the application.
4. Include a **self-addressed, stamped envelope** if you would like your photos returned.
5. Must be able to drop off artwork on designated drop-off date Monday, October 3rd between 7 and 9 p.m., and pick up artwork on Monday, December 5th between 7 and 9 p.m.

LAC Rules for Submission &

Exhibition of Art Works

- A **maximum of three pieces** of work per artist may be submitted with a maximum of **two photos per piece**. On all photos, please indicate the top and then mark the back with your name and the title of the piece. **Enclose a self-addressed stamped envelope** if you would like photos returned.
- There will be a **\$10.00 non-refundable hanging fee*** per artist (checks made payable to LAC).
- A **signed Statement of Release** must be included with **the completed application**.
- All work must be original.
- The size of the works (including frame) not to exceed 36" in width per this show's restrictions.
- Artwork limited to wall art.
- All art must be framed or painted around the edges of the canvas and ready to hang; saw-tooth hangers will not be accepted. Works will be rejected if not properly prepared.
- Artwork that is accepted for exhibition must be labeled on the back with the artist's name, the title of the piece, and media.
- Special installation needs (i.e., electricity) will have to be clarified and approved in advance by the coordinator.
- National University of Health Sciences (NUHS) and the Lombard Arts Coalition (LAC) have the right to reject any piece of artwork it deems inappropriate for exhibition in this gallery.
- Any work sold during the show must stay for the duration of the show.
- 20% of any sale goes to Lombard Arts Coalition.
- Artwork **for those artists juried into the show** must be dropped off on Monday, October 3rd between 7 and 9 p.m. and picked up on Monday, December 5th between 7 and 9 p.m.

* **Please note that this is a juried show** and that application to participate does not guarantee acceptance. The \$10 hanging fee is non-refundable.
